Pursuant to the Regular Local Election Act, NMSA 1978, Sections 1-11-2 to 1-11-3, I, Mike Milam, Clerk of the County of Valencia, by virtue of the authority vested in me, do hereby issue the following Notice of Election;

That a Regular Local Election is called to be held in the County of Valencia and precincts thereof on the 2nd day of November 2021; and

The Polls shall open at 7:00 a.m. on November 2nd, 2021 and shall close at 7:00 p.m. on November 2nd, 2021; and

The last day for Absentee ballots to be accepted by mail or in person in the County Clerk's office is by 7:00 p.m. on November 2nd, 2021; and

That a Regular Local Election shall be a nonpartisan election, and the names of all candidates shall be listed on the ballot with no party or slate designation: and

For the purpose of permitting qualified registered voters of the City of Belen, County of Valencia, New Mexico to vote for the purpose to elect one Mayor, two City Councilors and one Municipal Judge and to vote to impose a General Obligation Bond Question; and

For the purpose of permitting qualified registered voters of the City of Rio Communities, County of Valencia, New Mexico to vote for the purpose to elect one Mayor, two City Councilors and one Municipal Judge; and

For the purpose of permitting qualified registered voters of the Town of Peralta, County of Valencia, New Mexico to vote for the purpose to elect one Mayor, two Town Councilors and one Municipal Judge; and

For the purpose of permitting qualified registered voters of the Village of Los Lunas, County of Valencia, New Mexico to vote for the purpose to elect one Village Councilor District 1, one Village Councilor District 3 and one Village Councilor District 4; and

For the purpose of permitting qualified registered voters of the Belen Consolidated Schools District No. 2, the Counties of Valencia and Socorro, New Mexico to vote for the purpose to elect Board Members (Positions 4 & 5) and vote to impose a Property Tax Question; and

For the purpose of permitting qualified registered voters of the Los Lunas Schools District No. 1, County of Valencia, New Mexico to vote for the purpose to elect Board Members (Positions 3 & 5); and

For the purpose of permitting qualified registered voters of the University of New Mexico-Valencia, County of Valencia and Socorro, New Mexico to vote for the purpose to elect Advisory Board Members (Positions 1 & 4); and

For the purpose of permitting qualified registered voters of the Valencia Soil and Water Conservation District, the Counties of Bernalillo, Cibola, Sandoval, Socorro and Valencia, New Mexico to vote for the purpose to elect Board Members (Positions 2, 3 & 4); and

BOND AND PROPERTY TAX QUESTIONS

Only qualified registered voters of the City of Belen, shall be eligible to vote on the following question:

"Shall the City of Belen issue up to \$2,500,000 of general obligation bonds, to be repaid from property taxes, for the purpose of acquiring, constructing, purchasing, equipping and/or improving a police station, including acquiring land therefore?"

FOR General Obligation Bonds
 AGAINST General Obligation Bonds

Only qualified registered voters of the Belen Consolidated School District No. 2, County of Valencia and Socorro, New Mexico shall be eligible to vote on the following question:

"Shall the Belen Consolidated School District No. 2 continue impose a property tax of \$2.00 per each \$1,000.00 of net taxable value of property allocated to the Belen Consolidated School District No. 2 for the property tax years 2022, 2023, 2024, 2025, 2026 and 2027 for the purpose of: (1) erecting, remodeling, making additions to, providing equipment for or furnishing public school buildings, including teacher housing and pre-kindergarten classroom facilities; (2) purchasing or improving public school grounds; (3) maintenance of public school buildings, including teacher housing, or public school grounds, including the purchasing or repairing of maintenance equipment, participating in the facility information management system as required by the Public School Capital Outlay Act [Chapter 22, Article 24 NMSA 1978] and including payments under contracts with regional education cooperatives for maintenance support services and expenditures for technical training and certification for maintenance and facilities management personnel, but excluding salary expenses of school district employees; (4) purchasing activity vehicles for transporting students to extracurricular school activities; or (5) purchasing computer software and hardware for student use in public school classrooms; (6) purchasing and installing education technology improvements, excluding salary expenses of school district employees, but including tools used in the educational process that constitute learning and administrative resources, and which may also include: (a) satellite, copper and fiber-optic transmission; computer and network connection devices; digital communication equipment, including voice, video and data equipment; servers; switches; portable media devices, such as discs and drives to contain data for electronic storage and playback; and the purchase or licensing of software licenses or other technologies and services, maintenance, equipment and computer infrastructure information, techniques and tools used to implement technology in schools and related facilities; and (b) improvements, alterations and modifications to, or expansions of, existing buildings or tangible personal property necessary or advisable to house or otherwise accommodate any of the tools listed in (6) above."
